MCA Officer Candidate Process:

This year we are voting on candidates for **President Elect**-**Elect** and **Secretary**.

- The President Elect is responsible for coordinating conference programs and has the opportunity to shadow the President and Strategic Planning Committee in order to learn the role and continue the forward progress towards MCA's mission and goals.
- The Secretary is responsible for taking the official minutes of the organization and maintaining the records of the organization. This position requires a good mind for detail and numbers.

Below is the process that candidates will follow for the election.

- Candidates are to make their OWN election poster, mounted on foam board. Size: No larger than 16"x16"
- Bring candidate boards Wednesday 11/04 to display on an easel in the main lobby, near voting station.

Candidate for Secretary


Karla Weir
